- 1. The Romanian Government has received financing from the World Bank toward the cost of the Health Sector Reform Improving Health System Quality and Efficiency Project (HSRIHSQEP) Additional Financing and intends to apply part of the proceeds toward payments under the contract for Civil works for "Building a burn center and reorganization of the medical flows of the hospital in order to better position and connect ER, ICU and surgery departments for "Grigore Alexandrescu" Children's Emergency Clinical Hospital in Bucharest"
- 2. The Ministry of Health Project Management Unit now invites sealed Bids from eligible Bidders for the construction of a burn center in the Emergency Clinical Hospital for children Grigore Alexandrescu and the reorganization of existing medical flows, as well as the construction and reorganization of the technical annexes serving the hospital building, following the construction of the new building. The Emergency Clinical Hospital for children Grigore Alexandrescu is located in Bucharest, Bd. Iancu de Hunedoara no. 30-32. This project aims to create a Burn Unit and to reorganize the medical flows within existing buildings and wings.

To be done:

- 8 operating rooms
- Sterilization station
- 36 beds for the AICU, out of which 14 for Neonatology
- on-call doctors rooms
- outpatient for plastic surgery
- 2 operating rooms for the Burn Unit
- 10 beds for critical patients
- 16 beds for AICU for intermediary + post-critical patients
- 10 beds microsurgery and reconstructive surgery

The new building will be interconnected with the existing Emergency Room and with existing Building J and will have a built area of 2400 sqm, height regime B+GF+4F+5Teh and an overland area of 13700 sqm. The total duration of the works contract is 26 months.

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers- Procurement in Investment Projects Financing" fourth edition, issued in November 2020 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.

- 7. All Bids must be accompanied by a *Bid Security* in amount of *EUR 1,000,000* (one million *EUR*) or RON 5,000,000 (five millions lei).
